

## **MATCH & WIN WITH B-WELL**

### Terms and Conditions (“Rules”)

#### **1. Promoter**

The “Match & Win” promotion (“Promotion”) is organised and run by Southern Oil (Pty) Ltd (“Southern Oil”, “we”, “us”, or “our”).

#### **2. Eligibility**

The Promotion is open to individuals who:

- are 18 (eighteen) years or older; and
- are residents of South Africa.

Unfortunately, Southern Oil (Pty) Ltd staff members and immediate family members, distributors and subsidiaries are not eligible to win.

By entering the Promotion, you (“participant” or “you”) confirm that you meet these eligibility requirements and agree to be bound by these Rules.

#### **3. Promotion Period**

The Promotion starts at 10:00am on 13 January 2026 and ends at 23:59pm on 13 February 2026 (“Promotion Period”).

#### **4. How to Participate**

To enter the Promotion, participants must:

- play the “Match & Win” game available on [www.bwellfoods.co.za](http://www.bwellfoods.co.za); and
- achieve the fastest recorded time either:
  - on a specific day to qualify for a daily prize; or
  - for the relevant week ending to qualify for a weekly prize.

#### **5. Number of Entries**

Participants may play and enter the game an unlimited number of times during the Promotion Period.

#### **6. Prizes**
